INSTRUCTIONS

- **1.** Model A will be used when the affected party wishes to oppose the processing of their personal data, for reasons related to their particular situation, in any of the following situations:
- The processing of your personal data is being carried out based on a mission of public interest or in the exercise of public powers conferred on the data controller.
- The treatment of my personal data is being carried out based on the satisfaction of legitimate interests pursued by the data controller or a third party.

In these first two cases, the mere exercise of the right of opposition entails the limitation

- The processing of my personal data is being carried out for the purpose of scientific or historical research or statistical purposes.



Model B. will be used when the affected party wishes to object to the processing of their personal data for direct marketing purposes, including profiling.

- 2. The applicant must be sufficiently identified in the application, which must be signed. If the request is made by a third party, the representation granted for it must be duly accredited. You should know that, when the data controller has reasonable doubts regarding the identity of the natural person making the request, he may request that the additional information necessary to confirm his identity be provided.
- 3. The Spanish Agency for Data Protection does not have your personal data and can only provide the contact details of the Data Protection Delegates of the entities obliged to designate one that has communicated their appointment to the Agency. You can also provide these contact details regarding those entities that have designated a Delegate voluntarily and have communicated it.
- **4.** The owner of the personal data that is the object of treatment must go directly to the public or private body, company or professional that he presumes or is certain to possess his data.
- **5.** In order for the Spanish Agency for Data Protection to be able to process your claim in the event that your request to exercise the right to object has not been met, it is necessary that one month have elapsed without the person in charge having made the right effective, and provide any of the following documents:
- The refusal of the data controller to oppose the data requested.
- Copy stamped by the data controller of the opposition petition model.



- Copy of the opposition request model stamped by the post office or copy of the receipt of the shipment by certified mail.
- Any other means of proof provided by the data controller and from which receipt of the request can be deduced.
